## Directions:

From El Centro take Hiway 111 north to Frink Road, which is about 15 Miles north of Niland. The right turn is about 1/4 mile prior to the border check station on Hiway 111. If you are traveling south on Hiway 111 the left turn is about 1/4 mile south of the border check.

Travel on Frink Road for about 2 to 3 miles and make a right turn into the gravel pit, go approx. 200 to 300 yards. There are a couple of very nice flat areas that should accommodate all of our rigs. We will be about 200 to 300 yards off the paved road.

If reach Lark Spa you have gone to far. Go back about 100 yards and make a left.

## Other Stuff

Early arrival, Wednesday or Thursday, OK.

Bring plenty of water and fire wood. Fires in containers only,  
carry out your ashes.

All vehicles on the trek must be 4 wheel drive.

Make sure you bring along a good pair of binoculars and a camera.

Make sure to bring your signed "Release of Liability" on the back with you  
for each person.
